Land Use Committee Approves Bus Garage, Restricts Use of Telegraph Road

At its meeting on November 8th, the Lee District Land Use Committee considered the application of the Washington Metropolitan AreaTransit Authority (WMATA) for construction of a bus storage area and service garage on Cinderbed Road. This facility will replace the existing facility on Royal Street in the City of Alexandria.

The parcel of land has been before the Land Use Committee a number of times. It is a site with a history of environmental problems and zoning violations. The Committee agreed that the proposal submitted by WMATA would represent a major improvement.

Members of the Committee from the Telegraph Road corridor, including those from Virginia Hills (Doug Boulter), Wilton Woods, Tartan Village, Burgundy Village, and Manchester Lakes were extremely concerned about the buses using Telegraph to go to and from their routes.

The Committee ascertained that there are currently 62 buses using the Royal Street garage, and initially the number could go to 80 at the new facility. The facility would be designed for 160 buses in total to accommodate future expansion. Of these, 35% might use Telegraph during early morning (4:00-5:00 AM), mid-afternoon (2:00-3:00 PM), and early evening (7:00-8:00 PM). The poi9nt was made by several members that the buses would not be serving routes on or near Telegraph Road -- or many of them even in Fairfax County. When a substantial number of Committee members indicated that they could not support the plan if that volume of buses were to use Telegraph, WMATA asked for time to re-look its proposal.

Now, the VHCA is engaging with Supervisor McKay's office and VDOT about the proposed change to rules governing truck traffic on the Groveton side of South Kings Highway that may result in an increase of truck traffic through our neighborhood. I hope to have good news regarding this issue in our next issue of the *Echo!* In the meantime, have a wonderful holiday season and please remember to reach out to your neighbors -- especially elderly neighbors in the event of snow!





All of Virginia Hills Back in the Mount Vernon Police District

Several years ago, coverage of the Virginia Hills neighborhood was divided between the Mount Vernon police station and the Franconia station. This was done because part of Virginia Hills was in the same map sector as Lee District Park, and the park was much more accessible from the Franconia Station. As a result, Virginia Hills had two crime prevention officers and two community advisory council meetings to attend. Virginia Hills residents were served by different stations, depending on the street on which they lived.

President Boulter and President Zecca have been working with Master Police Officer Greg Kotterman, Mount Vernon's Crime Prevention Officer, to put Virginia Hills back into one police district or the other. There was agreement in the police chain of command that this should happen. The delay was due to the need to work out the technical details.

Officer Kotterman has notified VHCA that the neighborhood is now entirely within the Mount Vernon police district again, and that calls to the dispatcher will have a Mount Vernon officer responding.

Next project: Getting all of Virginia Hills into the same electoral precinct.

At the meeting on November 15th, WMATA came back to the Committee and announced that it had modified its plan so that the buses originally to be routed on Telegraph Road would use Route 1 instead unless they were serving a route on or just off of Telegraph. With this proffered condition, the Land Use Committee approved the requested special exception to allow the garage to be built.

Message from Supervisor McKay

As your local elected official, I take sidewalk level issues seriously and make a point to get into our neighborhoods as often as I can. Neighborhoods that I'm accustomed to seeing in the light of day take on a different cast when seen at night from the passenger seat of a police car. While I often tour my district with the police, it's usually during the day. Recently, I joined Captain Shawn Bennett, commander of the Franconia police station, on a ride-along from 9:30 pm to midnight. (Captain Dave Moyer commands the Mount Vernon station that covers the Virginia Hills area of Lee District.) You can read more about public safety at

www.fairfaxcounty.gov/police/stations/mountvernon

Our drive-along included a good part of the district, focusing on neighborhoods where individuals had requested additional police presence or where there were a number of calls for service. (That's why it's important for you to call the police if you see or hear something worrisome in your neighborhood — police resources are allocated in part by calls for service.) During the ridealong, I saw our police bike team patrolling shopping centers and neighborhoods; those officers know every inch of our district. They have a

true sidewalk-level perspective and with the flexibility and mobility of a bicycle, they can do things that police in cars cannot. They're one of the reasons that our police officers are on a first name basis with many of our residents—both the good ones and the bad ones.

Thanks to this ride-along, I saw some things that need correction and I'm now pushing for action. For example, we need a guardrail along sections of the Franconia-Springfield parkway, and we need additional lighting in the Rose Hill Shopping Center.

Overall, Fairfax County and Lee District are very safe communities — among the safest in the entire country. While we expect a high level of service in Fairfax County, I think this is even more impressive when you consider that our police force has fewer police officers per 1,000 residents than any other suburban area in our region. (The Franconia station has 140 sworn officers and 30 civilians and the Mount Vernon station staffing includes 157 sworn officers and 31 civilians.) That's why I insisted that our budget reductions spare our public safety forces as much as possible.

After this recent ride-along, I have a renewed appreciation for the dedication and commitment of our public safety forces.
